Dedicated obesity and weight management services cost £636k in 2023/24. In addition to this, total surgeon costs of £1.48 million were incurred however, whilst surgeons carry out a range of bariatric surgical activity/clinics their time is shared with other general surgery activity. Therefore an element of this cost will be non weight management related.
